
The Carroll Community College Foundation and its Board will seek resources to turn the hopes and dreams of our students and the communities we serve into reality by developing long-term relationships with our donors.

Recurring Donations are made on a periodic basis to spread the financial impact of a donor's giving across the entire year.


Scholarships provide empowering, accessible, high-quality education for credit and noncredit students pursuing degree, certificate, and other program completion.

Long-Term Commitments or Pledges can be paid over a period of years to support long-term, strategic funding and programmatic needs. Major Giving

Individuals and families can transform lives, innovate programs, and sustain scholarship opportunities over time through major gifts of \$10,000 or more. These impact commitments significantly advance the Foundation's mission and vision by funding specific programs, endowed scholarships, and strategic initiatives. **Endowments** are funded through a donation of money or assets of \$25,000 or more. The resulting investment income will be used in perpetuity to fund a specific program, strategic initiative, or scholarship. Endowments may be named by the donor to ensure a legacy of support for future generations.

Gifts of Appreciated Stock, Mutual Funds, and Marketable Securities may enable donors to make a larger gift at a lesser cost basis while providing significant tax benefits through income tax reduction and elimination of capital gains taxes.


Long-Term Commitments or Pledges are multi-year commitments paid over three to five years, enabling the donor to make contributions that support long-term strategic goals and planning.

Retirement Assets and Charitable IRA Rollover Gifts may count towards a Required Minimum Distribution (RMD) and provide significant tax benefits to the donor.

Legacy Giving

You can impact the lives of thousands of students each year by contributing to Carroll in your personal legacy. Legacy giving secures the future of high-quality educational programs to advance careers, enrich lives, and strengthen our community for many years to come. **Bequest** is the act of giving specific assets (e.g., stocks, bonds, cash, art, jewelry, and/or real estate) to the Foundation through the provisions of your will or estate plan.

Charitable Gift Annuities are gifts that provide a donor and/ or their loved ones with income for a duration of time and the Foundation with the remainder of the donation.

Donor Advised Funds serve as a personal charitable savings account that provides an immediate tax deduction to the donor. A sponsored organization invests the donor's assets and disperses the donation to the Foundation.

Life Insurance Policies may be transferred or purchased for the Foundation to make a gift plan that defines your legacy.

Retirement Assets may be designated or transferred by indicating the Foundation as beneficiary.




